## Title and Abstract

Title Pemaknaan Kebijakan Kriminal Perbuatan Santet dalam RUU KUHP

Abstract Santet kerap kali menimbulkan keresahan masyarakat, belum ada hukum positif yang mengatur tentang santet. RUU KUHP Nasional yang akan datang, santet dirumuskan dalam Pasal 252. Politik hukum dalam memformulasikan santet hanya menjangkau dimensi perbuatan bukan akibat dari perbuatan tersebut. Penelitian ini bertujuan menganalisis konstruksi nilai dan pemaknaan kebijakan kriminal perbuatan santet. Hasil kajian menunjukkan, bahwa berdasarkan maksud dari Pasal 252 mencegah praktik main hakim sendiri, konstruksi nilai dibangun berbasis pada ide dasar pencegahan berorientasi pada kebijakan perlindungan masyarakat (*social defence policy*). Perspektif nilai yang ingin ditegaskan tercermin dalam teori relatif dicirikan bahwa tujuan pidana adalah mencegah kejahatan terjadi dan sebagai sarana memperbaiki pelaku kejahatan. Pemaknaan normatif, santet merupakan delik formil yang dilarang adalah perbuatannya bukan akibat yang ditimbulkan. Pemaknaan integrasi-sosial ialah upaya mendukung terwujudnya masyarakat yang patuh hukum maka kriminalisasi santet ditujukan pemeliharaan stabilitas masyarakat agar saling melindungi tidak membalas dengan perbuatan main hakim sendiri.
